





- Shapes the Center's strategy and informs its programs.






















#### Many Sectors, One Group

#### **Multisector Partner Group**

#### **Expectations of Members:**

- Bring your authentic self to all activities and work.
- Actively participate in all meetings and activities.
- Serve as a thought leader and contribute to the Center's strategy, programs, and collaboration-building work.
- Amplify communications about health equity and health justice.
- Complete all pre- and post-meeting work.
- Time commitment will be up to 5 hours/month for 3 years.



#### **Application Process and Requirements**

#### The Center for Health Justice launched the Call for Applications for the Multisector Partner Group on October 22, 2024

- Applicants can only apply online. You must have an account with CadmiumCD to apply. New Users should create an account.
- Applicants can either apply as an individual or as an organization.
- Deadline to apply: December 20, 2024.

#### Components of the application

- Applicant type
- Personal information
- Application questions
- Supporting documentation



#### **Review and Selection Process**

A selection committee will review applications after the submission period closes.

#### **Criteria for Applicants**

- Align with the AAMC Center for Health Justice's goal to make a significant impact on health equity.
- Demonstrate relevant health equity activities.
- Display interest in being a member of the Multisector Partner Group.
- Ability to build, nurture, and manage relationships with your audience and/or disseminate information to the public about our work.



#### **Key Dates and Deadlines**

Application Opened	October 22, 2024
Application Closes	December 20, 2024
Applicants Notified	February 2025
Term Begins	March 2025
In-person activities in Wash., DC	April 10-11, 2025
Virtual Meetings	Second Monday of each month
